PROGRAM APPLICATION (application packet will be provided during tour)

- Application Priority Deadline: March 15
- o Late / illegible / incomplete application packets will not be considered
 - Application must be submitted as a <u>"packet of documents"</u> (see EPT Application Checklist)
 - DO NOT submit individual documents and attempt to verify what PCC has received.

□ PRE-REQUISITE/ PLACEMENT REQUIREMENTS:

- MATH- applicant must be ready for or already completed Technical Math or higher (must meet one of the following requirements)
 - 19 or higher in math on the ACT
 - o Testing into Technical Math or higher on the ACCUPLACER placement test
 - Successful completion of Technical Math or higher (i.e. intermediate algebra or college algebra)
- ENGLISH/READING (must meet one of the following requirements)
 - \circ 18 or higher in Reading on the ACT
 - Testing **out of** Basic Reading / Scoring a minimum of 69 in reading on the Classic ACCUPLACER or 245 in reading on the Next Generation ACCUPLACER placement test
 - Successful completion of English Comp I

□ OFFICIAL TRANSCRIPTS

Official transcripts from High School/GED and ALL colleges attended are required.
Submit official copies of your high school transcript or GED certificate (if applicable) and transcripts from any college previously attended to the Registrar's Office

- Order requests or statement verifying sent via mail must be included in the "application packet"
